We wanted to let you know a few things about the contest so you can prepare appropriately. ***We will be including the math practicum component of the Food Science Contest.*** The math practicum will include 5 math problems worth 5 points each for a total score of 25 pts. per student and 100 pts. per team. The product development team activity will be the final event of the day and there will be down time during the presentations of other teams. The areas of focus for the product development activity have been decided and will focus on a product that meets the following criteria:

- Category: Beverages
- Platform: Refrigerated
- Market: Convenience Store
